

7. Please add any feedback/concerns about returning to school:

***This question was not required. The district received 287 responses. The following are themes from the responses.

- Prefer full-time remote/online option; a return to in-person is not worth the risk
- Health concerns in the building (i.e. the ability to comply with CDC guidelines)
- Concerns with teachers' workload and familiarity with available tools (i.e. Zoom, Canvas, prep time)
- Concerns with proper cleaning/sanitizing in the buildings
- Would prefer a change to the A/B hybrid schedule to allow for 4 days per week of in-person instruction and one day for deep cleaning/sanitizing
- SPED/IEP/504 plan concerns
- Medical concerns for an at-risk family member
- Confident that we can return to in-person instruction safely
- Concerns over wearing a mask without proper ventilation or available air-conditioning
- Concerns with available child care
- Personal medical concerns
- Concerns with the proposed educational method
